NATIONAL WORKSHOP "IMPLEMENTING THE WTO TRADE FACILITATION AGREEMENT"

In December 2013, WTO members concluded the negotiations of the Agreement on Trade Facilitation (TFA) at the 9th Ministerial Conference in Bali. Upon entry into force, the TFA will create binding obligations for WTO members to improve customs procedures, transparency and efficiency as well as cooperation amongst border regulatory agencies and private sector. The developing and least developed Members shall self-designate, on individual basis the provisions of the TFA into Category A (implementation upon entry into force), B (deferred implementation) or C (linked with acquisition of capacity through assistance and support) and the date of their choice for the implementation of respective provisions.

This two-day workshop will gather public and private trade facilitation stakeholders to determine Tajikistan target categorization of the TFA commitments for notification to the WTO and initiate the process of building project plans to request donors financial and technical assistance for Category C provision implementation. Discussion will build on the WTO Needs Assessment conducted by COUNTRY in 2009 (year).

Key questions driving the discussion

For each of the 37 Trade Facilitation Agreement provisions, the following questions will be submitted to discussion in order to determine the appropriate categorization:

- What could be the appropriate category for this measure?
- Is Tajikistan already implementing this measure?
- What laws and/or administrative instructions correspond to this measure?
- What type(s) of actions are required to implement this measure, including incurring costs?
- What would be the resources required to implement this measure?
- How much time (in months / years) would be required to implement the measure?
- Do you need any external assistance for the implementation of this measure?
- How important is the implementation of this measure for the overall national development strategy?
- Do you think implementation of this measure would require some other measure to be implemented prior to this measure?
- In your opinion, which Ministry / department is best suited to lead and ensure implementation of the measure?
